Grant Presentation/Handicap-Accessible Changes: Jim Lytle spoke about the presentation to the Whittemore Fund Grant Committee and his progress with the construction estimate to make the men's bathroom handicapaccessible.

Judy moves that we utilize Rob Bunn, as the contractor to implement the handicap accessibility at St. Mark's as further defined. Gerry seconded the motion. Discussion. Motion approved.

Discussion as to what we can afford and what we should present to the Whittemore Foundation. Right now there is \$2,369 in the Marie Fund. Judy moves that the funds in the Marie Fund, which is a part of the St. Mark's Building Fund, be used as our contribution towards the handicap-accessibility improvements at St. Mark's. Jean seconded the motion. Discussion. Motion approved.

Regarding the Whittemore Foundation Grant Meeting at St. Mark's, Grand Rapids - Friday, Oct 25, 2 p.m. Gerry and Larry and Rebecca will attend the meeting.

After Jim reviewed the Grant application with us, Judy moves that we submit our application to the Whittemore Foundation to include the bathroom downstairs, the two chairlifts, ramp and modifications to the interior. Larry seconded the motion. Discussion. Motion approved.

Jim will contact Rob Bunn first thing in the morning and get the final estimates. He will then submit the application electronically to the Whittemore

Foundation.
